### HEALTH AND PREPERATION

2016 Runners trip will require a signed health document from your physician.



For European running events a health document is needed for participation. For 2016 a simpler document is needed for foreigners participating in an event, and when RiAdvTvl has the document we'll forward it to you. Further documents will be forthcoming to you about health, and preparation for running.

As important as bringing the right gear is being physically, and mentally ready for an active travel trip.

Your trip is an adventure that goes to destinations, places and situations that are often isolated or remote where medical facilities may not be available, are difficult to reach, or may require many days of travel to reach. Should you have questions about trip difficulty and your fitness level, feel free to call and chat with us.

You are encouraged to contact your physician for medical advice, and to obtain appropriate inoculations and or medications. Let your medical provider know where you are going and what you will be doing. You will also wish to discuss with your physician what your preparation and participation would involve.

**Please answer the questions below.** Again, good physical shape, mental and emotional fitness are essential for reducing risk of injury, and maximizing the enjoyment of your adventure.

This document lists terms and conditions of your agreement with Ri Adventure Travel; please refer to the Trip Departure page and your specific itinerary for important details and information about what's included and not included in the price of your trip. **Please sign this form and return it to us as soon as possible.**

By advancing deposit to Ri Adventure Travel, the depositor therefore agrees to be bound by the below terms and conditions.

**What's not included on any of our departures?**

- Personal gear (rain gear, hydration systems, etc.), a trip gear list is sent with your confirmation package.
- Trip Cancellation and / or emergency evacuation Insurance
- Alcoholic beverages
- Guide and Staff gratuities
- Flights, both international and internal
- Expense of your travel documents: Your passport, international inoculation card, or visa's that may be needed for entry to the countries you are visiting unless otherwise stated on the trip itinerary.

**Additional costs** (Your PrepToGo package will cover many of these details.) Your adventure may have some meal(s) not included. You should consider bringing additional funds for those meals. Ex. \$12 for lunch and \$18 for dinner. Budget for beer, wine, etc. too. A last item to consider is the "Thank You." Tipping the expert running guides, and the bus driver is your choice and is commonly done. A suggestion would be Lead Guide \$12 per day, helping guide \$8 per day, bus driver \$5 per day. Tipping total around \$350, give or take. We'll talk more about this and many other topics in the PrepToGo package and Final Package.

If you as the participant need a rescue, or are required to leave the trip before completion, or cannot depart a location as scheduled, you will be responsible for any expenses incurred. Ri Adventure Travel LLC is not responsible for unexpected expenses for which it has no control.

**Reservations and Payments** Reserve your trip by mailing a check or by calling RiAdvTvl with your credit card information. If you prefer to use a credit card RiAdvTvl LLC will add 3% to that payment to cover bank fees. Cards accepted: Visa, and MasterCard.

**The reservation deposit and cancellation policy may differ** on a select few trip itineraries from this policy, those differences are noted on that specific itinerary. Your trip reservation deposit: \$600 per person unless otherwise noted on your trips itinerary. Trip balance is due at 70 days prior to departure. There is a cost advantage by using a personal or cashier's check to secure your reservation. If you would like to use a credit card, then RiAdvTvl add 3% to your deposit or balance.

**Trip Minimums** In order to confirm any Ri Adventure Travel departure, a minimum number of participants must make a reservation. **Trip Cancellations** I understand that Ri Adventure Travel (RiAdvTvl) reserves the right to cancel all or a portion of a trip for force majeure or any other circumstances beyond our control and, in the event of such cancellation, full or partial refunds, if any, will be at RiAdvTvl sole discretion. We also reserve the right to cancel any trip if reservations are inadequate to make the trip economically feasible for us to operate, and in



this event, we provide a full refund of the trip price. However, RiAdvTVI is not responsible for additional expenses incurred by you in preparing for the trip (e.g., non-refundable air tickets, a passport, visa fees if applicable, gear or medical expenses, and items of a personal nature).

Ri Adventure Travel LLC specifically includes its owners, agents, employees, representatives and affiliates. Ri Adventure Travel LLC does not own or operate any entity that provides goods or services for your trip including, but not limited to, ownership or control over hotels or other lodging facilities, airline, vessel, bus, van or other transportation companies, local ground operators, providers or organizers of optional excursions, food service or entertainment providers, and force majeure. All such persons and entities are independent contractors. As a result, Ri Adventure Travel LLC is not liable for any negligent or willful act or failure to act of any such person or entity, or of any other third party.

The activities of the active adventure travel trip which you are to participate in has risks. The intent is not to frighten you or reduce your enthusiasm for these activities, but it is important for you to know in advance what to expect and to be informed of the potential risks. The following are some of the activities which you may experience: hiking, bicycling, mountaineering, rafting, river crossings, climbing mountain ridges, canopy tower, traveling by van or bus or truck, traveling by train, traveling by horse, kayaking, canoe, reed boat, motor boat, yacht, traveling on foot on and off-trail, uneven terrain, loading and unloading gear, carrying and moving duffel bags, be near live stock, and wildlife viewing.

These activities entail risks, including risks which cannot be eliminated without destroying the unique character of the activities. The same elements that contribute to the unique character of these activities can cause loss or damage to equipment, injury, illness or death. Some, but not all of these risks, include: drowning, prolonged exposure to cold water; pick-pockets; being struck by or falling against a rock or sharp object while hiking; slipping on wet surfaces, falling while transiting to / from a vessel, intense cold, heat, sun, snow, rain, flood, earthquake, above average smog, fog and wind; guide misjudgment; consumption of alcoholic beverages; crevasses, contact with poisonous insects and wild animals; contact with domestic and farm animals, sand storms; negative reaction from air or waterborne bacteria or virus; sanitation problems, food poisoning, lack of access to or quality of medical care, hypothermia, prolonged delay in ability to obtain medical assistance (evacuation to medical facilities could take more than 24 hours); transportation failures; forces of nature such as rock falls, avalanches, and floods; breakdown or faulty equipment; transportation failures or delays, and losses due to civil unrest and terrorism or for any other cause beyond the direct control of Ri Adventure Travel LLC. All Ri Adventure Travel trips allow for unsupervised free time. Free time activities are not part of the Ri Adventure Travel trip and are at your sole risk. Ri Adventure Travel LLC is not responsible for any loss, injury, illness or death which may result from your participation in free time activities. In addition, I release Ri Adventure Travel LLC from its own negligence and assume all risk thereof.

I agree to assume responsibility for the risks identified in this document and for those risks not specifically identified. My participation in the Ri Adventure Travel trip is purely voluntary; no one is forcing me to

participate. I am voluntarily participating in this trip with knowledge of the numerous risks and dangers involved including, but not limited to, those listed above
