Your reservation deposit: \$500 per person unless otherwise noted on your trips itinerary.

Trip balance is due at 60 days prior to departure.

There is a cost advantage by using a personal or cashier's check to secure your reservation.

Payments made by check will receive a reduced land cost of 3%.

Cancellation Schedule

91 or more days prior to departure, no fee

61 to 90 days prior, the deposit is forfeited.

60 to 31 days prior, 50% of Land Cost is forfeited.

30 days or less, 100% of Land Cost is forfeited.

Cancellation notice is based on when it is received in writing by mail or email.
